- 6. Voter Approved Physical Plant and Equipment Property Tax. Director Rohrbeck introduced the following Resolution and moved its adoption. Second by Director Thielen. Ayes Schulze, Rohrbeck, Koehler, Thielen, Squibb. Resolution ordering election on the question of levying a voter approved physical plant and equipment property tax. Whereas, this Board has determined that an election should be called on the question of levying a voter approved physical plant and equipment property tax. Now, therefore, it is

resolved by the board of directors of the Glidden-Ralston Community School District, in the Counties of Carroll and Greene, State of Iowa: That an election is called of the qualified electors of the Glidden Ralston Community School District, in the Counties of Carroll and Greene, State of Iowa, on Tuesday, March 4, 2025. The following public measure is approved, and the Secretary is authorized and directed to submit and file the public measure for the Ballot with the Carroll County Commissioner of Elections at least 46 days prior to the election. Shall the Board of Directors of the Glidden-Ralston Community School District, in the Counties of Carroll and Greene, State of Iowa, for the purpose of purchasing and improving grounds; constructing schoolhouses or buildings and opening roads to schoolhouses or buildings; purchasing of buildings; purchase, lease or lease-purchase of technology and equipment; paying debts contracted for the erection or construction of schoolhouses or buildings not including interest on bonds; procuring or acquisition of libraries; repairing, remodeling, reconstructing, improving, or expanding the schoolhouses or buildings and additions to existing schoolhouses; expenditures for energy conservation; renting facilities under Iowa Code Chapter 28E; purchasing transportation equipment for transporting students, lease purchase option agreements for school buildings or equipment; purchasing equipment authorized by law; or for any purpose or purposes now or hereafter authorized by law, be authorized for a period of ten (10) years, to levy annually, a voter-approved physical plant and equipment property tax not to exceed One Dollar Thirty-Four Cents (\$1.34) per One Thousand Dollars (\$1000) of the assessed valuation of the taxable property within the school district commencing with the levy for collection in the fiscal year ending June 30, 2026, or each year thereafter?
